The restaurant is going to close for 2-3 months. When the owner is ready to reopen, he will need to provide our office will all the paperwork and fees for the 2019 calendar year.

6:14 Discussion with Vijay Shah, owner of Green Acres Motel

Mr. Shah was asked to attend this meeting to discuss recent findings at a joint inspection with Health, Building, and Fire. At our last meeting, the board asked that this property empty of all guests so a complete inspection of the property could occur. The Health Inspector returned after 30 days to complete the inspection and here are the findings:

One room was occupied, the occupant told our office he has been living there for over 2 years and he was not healthy enough to move

The rooms has evidence of rodents, water damage, chronic dampness, and sagging floors and over all poor cleanliness. The building is not meeting minimum standards for human habitation.

The apartments in the main house were inspected at that time and it was discovered that they also do not meet code. The owner asked the board to allow him to open six rooms with cosmetic fixes and then do a complete renovation of the property later. At the recommendation of the Health Inspector, the board will only allow the Motel to open rooms or apartments when they are safe and up to code.
