# Appointment of Eric Rondina as a Part-Time Police Officer

The Selectmen were joined by Police Chief Ford. He presented a candidate to fill the vacant part-time police officer position, Eric Rondina. He is a Sturbridge resident and a graduate of the police academy where he was also the president of his class. He also served his country as a member of the Army & Navy.

#### **Department Head Reports**

Annie Roscioli presented herself as the Recreation Department Head. She informed the Board that they had a good Summer Camp and had over 30 new families and 135 participants. She provided updates on the adult sports leagues and the recent successful tree lighting. She updated the Selectmen on the court resurfacing project and the New York Trip which was sold out and may be expanded. The Ice Rink is coming soon. Plans for the Town Barn Fields are being reviewed and may be presented to the Town in the Spring.

Shane Moody presented himself as a representative of the Water Department. He is still waiting for November data so he only had his October report completed. He was happy to be meeting the zinc levels in our water. He has been meeting with the contractor for the Douty Road project. He reported that the public hydrants have been serviced for the winter. He reported that we are 98-99% compliant on the removal of contaminants which is common.

Greg Morse presented himself as the DPW Director. He informed the Board of an electric line installation project and WWTP upgrades to the four drums and his experiences dealing with the vendor. He feels that the Town is ready for the winter months given our equipment & supplies.

L. Gaumond informed the Board that the Town has received a request from the residents of Old Towne Way to have their street accepted as a public way. # **PUBLIC HEARING: Complete Streets Policy**

M. Dowling read the public hearing notice.

- L. Gaumond reminded the Board of Selectmen that on November 6<sup>th</sup> he presented to the Selectmen a presentation on complete streets. At that time the Selectmen requested a public hearing to consider the formal adoption of a complete street policy. The public hearing was scheduled for the meeting and was advertised in the local media as well as through his blog and through twitter. Greg Morse and Jean Bubon were present for the hearing as well as Dan Daniska from CMRPC.
- M. Dowling sought clarification of the use of these complete street funds to do projects in the state right-of-way. D. Daniska responded that probably could be done in the intersections of the state roads. There was a longer discussion regarding wayfinding signs and whether they could be done as well. After much discussion, D. Daniska thought we could probably work with the state on a project like that.
- M. Suprenant asked if adoption of complete streets would give us Massworks grant priority. J. Bubon wasn't sure but would look into it.

Bill Zelenak of 261 Holland Road addressed the Board to determine if this is something we need to follow for all Town roads. D. Daniska and J. Bubon responded that it is only where it would be possible as determined by the Town. He further asked if there are standards for sidewalk construction. D. Daniska stated that the standards for sidewalk construction are found elsewhere in the regulations.
