### Town Administrator Update

• Update E-1 Pumps

The Town sewer system has 2,147 accounts. Of those accounts, 68% do not have E-1 pumps. The majority of the remainder of customers who do have said pumps have equipment that was installed over 20 years ago – meaning not only the pumps are failing, but the other system parts as well, i.e. power cords and control panels. We are discovering now that with new pumps, rather than rebuilds, the original panels are far better to be replaced to avoid any risk of failure resulting in liability.

The number of replacements and rebuilds over the past eight years is significant – and costly. This year, alone, we have installed 53 new pumps. A new challenge that we are facing is that the supplier for our pumps/parts no longer recommends rebuilding as the individual parts are increasing dramatically in cost, and the labor is significant.

Currently, the budget line for E-1's is approximately 2.8% of the total. To cover the costs in 24, we would need to increase by 6.9% - with the total cost for E-1's comprising 9.1% of the budget – for 32% of the ratepayers.

If the Board wishes to continue to service E-1's, the Town will need to request a budget transfer for this year, and consider an increase for next year of 6.9% to cover this year in addition to the 3.5% the equipment is likely to increase next year.

- Selectman Mary Blanchard indicated that the residents are also responsible if they damage the pump.
- Chair Goodwin stated general places in Town that are serviced in town will not have an E-1 pump. Is the user that is using the pump station also using the E-1 pumps. He also asked if there is a part Town that the fails are more concentrated.
- Shane Moody, Veolia, stated they are all around town, not concentrated in one particular part. They now know the pumps cannot be repaired they are finding that they have to purchase new pumps. Approximately 100 pumps a year.
- Selectman Blanchard stated when the E-1 pumps were put in the Town did a lot of research that they were the best ones. The Town invested in the pumps to keep the lakes clean. She feels Veolia needs to predict better and budget better.
- Chair Goodwin stated they need more information we have a water/sewer budget change coming up. The costs to rebuild the pump has eclipsed the costs of the new ones.
- Selectman MaryLou Volpe asked when the pumps are being replaced are the panels being replaced and put in a higher location.
- Shane Moody, Veolia, stated yes they have to hire a licensed electrician to move the panel and place it in a more suitable location.
