Vice Chair Kaitbenski called meeting to order at 6:30 p.m. and read the agenda. The Selectmen led the Pledge of Allegiance.

Vice Chair Kaitbenski asked for a Moment of Silence for all the senseless violence going on in the world.

Public Service Announcements:

Vice Chair Kaitbenski congratulated Selectman MaryLou Volpe on being elected and wished her luck.

Reorganization of the Board:

Vice Chair Kaitbenski suggested that the board reorganization be held off until the full Board is in attendance.

Department Reports: Water and Sewer

- Shane Moody, Project Manager Veolia, reported that 20 pumps froze in one weekend in February due to the record-breaking extreme cold spell, the worst in Moody's memory. Staff members were able to thaw most of the pumps using heaters. Vice Chair Kaitbenski asked if there is anything homeowners can do to avoid having their pumps freeze during extreme cold. Mr. Moody said that while running water can help, there's not much that can help when

temperatures are exceptionally cold for exceptionally long. He reported that the department lost a pump station during the night, and by the time the generator got there, it was frozen solid.

- The water ban will work a little differently this year. As usual, when water goes down to a certain level, there will be the normal water ban; but in addition, starting this year, if the state declares drought status, there will no lawn-watering permitted whatsoever. The levels right now are very high Westville Dam is at 6,000 cubic feet per second, well below the 89 cubic feet per second to necessitate a ban; still, things can dry up fast.
- The water main job is going very well, progress is almost to the cemetery. Paving and hookups will be next week, and everyone is expected to be connected by the end of the month. Hydrant flushing is complete on the east side of town, and will now begin on the west side.
- As reported, the town was not happy with the state's paving job on Route 131. The state is correcting the problem and will fix the manholes and boxes.

Department reports: DPW

DPW Director Heather Blakeley reported:

- The Maple Street waterline work is going well. For now, the road is being patched. Paving will be in the fall or next spring.
- Bids for the parking lot at 501 Main Street are due next week. Ms. Blakeley said some potential bidders said they are having trouble finding granite curbing. Bids for the replacement for the media at the Water Treatment Facility have also gone out, and are due by the middle of May. The next bid out is for annual paving operations.
- Ms. Blakeley will begin the search for an Operation Manager. Additionally, she has interviewed several candidates for a heavy-equipment operator, and has one schedule to meet with the Board later in May.
- The department has been doing catch-basin cleaning as well as street sweeping. The town's older street sweeper failed a few days into being used, which has slowed progress. TA Grimm noted that a request for a new street sweeper is being added to the Annual Town Meeting Warrant to be discussed later in the meeting. Vice Chair Kaitbenski asked about outsourcing street-sweeping; Ms. Blakeley said it is difficult to find, and renting costs \$12,000 a month. She noted that the town has the labor available, just not enough reliable equipment. Ms. Blakeley said she will revisit the idea of outsourcing street-sweepers, which are used twice a year.

Town Administrator's Report

TA Grimm reported that she is being asked by the developers of the Amazon plant in Charlton to sign off on related adjustments to stoplights on Route 20 in Sturbridge. TA Grimm has no problem doing that, but she said it begs the question of why Amazon is being permitted to adjust area stoplights and put up a stoplight at the new plant, when Sturbridge is not permitted to put up

a stoplight at the new Noble Energy EV project because, as the state repeatedly tells Sturbridge, the DOT is against stoplights and is allowing only roundabouts.

Further, Noble Energy's roundabout will require taking property from neighbors, which the state will not do, meaning Sturbridge has to take the property through Town Meeting vote.

In fact, once the corridor is completely redone because of the Amazon traffic, the \$4 million roundabout and property-taking for Noble Energy may be proven unnecessary, which is why TA Grimm is asking to be allowed to put up a stoplight short-term.

Selectman Goodwin said he agrees, and thinks the Amazon-plant problems are even bigger than Ms. Grimm is reporting, and that the town should call on Rep. Todd Smola and Sen. Ryan Fattman, and even the governor to help.

Action Items:

A. Consideration and possible action on new septage rate for septage haulers and increasing the septage-receiving rate at the Waste Water Treatment Plant to 9¢/gallon starting June 1, 2023.

DPW Director Heather Blakeley joined Mr. Moody to discuss the new septage rate. The goal for taking in septage is to cover cost of hauling sludge to the plant in Cranston. Sturbridge is charging 7¢ a gallon now, which left the town \$22,000 short. The recommendation is to go to 9¢, which is what area towns are charging and a reasonable increase considering tolls, gas, etc. TA Grimm stressed that this does not impact Sturbridge residents. Board members agreed the increase makes sense.

Articles 41 and 42 are related to questions about whether Free Cash can and should be used for these sewer projects. It is agreed that the Route 131 line should come from Sewer funds, not Free Cash; while the Route 20 line can arguably be considered for Free Cash because the whole town, not just sewer-users, benefits from the businesses there. TA Grimm was told that the Finance Committee has never in the past supported using Free Cash for a Sewer project. An alternative would be a 50-50 split, although she cautioned that even without this, the Free Cash is down to about \$4 million. TA Grimm said the question comes down to whether the businesses in that stretch of lines between OSV and Route 131 generate enough business to warrant having some or all of the amount paid by town-wide taxes, not sewer taxes.

Selectman Goodwin said that this is not a good time to cover any extra costs from Free Cash; Vice Chair Kaitbenski agreed.
