# **Town Administrator Update**

• Immigrant Placement – Administrator Grimm advised the Board on the migrant situation which is currently not all confirmed information the State hasn't been providing actual information regarding exactly how many families are placed in Sturbridge. With the Governor declaring a State of Emergency the Town doesn't have a choice.

The State is engaging in a business transaction with the individual hotels. The State of Emergency allows the Governor the authority to extend the 30-day hotel stay. The Governor has the authority through the State of Emergency to override the Towns By-Laws.

- Big-Alum Dock Permits Upon a review of the docks on Big Alum there are no permits for those docks. Next year we will revisit the dock permits and the Selectmen's policies.
