## **Department Head Updates**

Chief Ford, Police Department

It is "Movember" and Chief Ford has given the police department to be allowed to grow a mustache in support of men's prostate health awareness in exchange for a minimum \$20 donation towards supporting prostate health. It is a great cause and also great for morale.

Calls for service were consistent through September and October. There was been a significant amount of training throughout the department. The new Animal Control Officer is exceling in the position and had been completing training as well. Calls to the schools were due to sports industry. Mr. Brent Young is still missing to date; the investigation is still active and the search continues. Standard Operating Procedure presented to the Board involves Protective Custody Law changes. The previous law only dealt with alcohol related challenges and will now cover opioid (or similar situations). The Board and Chief Board discussed the opioid crisis, Narcan use and overdose calls in Sturbridge.

#### Fire Chief Ford

Total runs are up 17% this year, mostly from EMS calls which are at 20% of total calls. Multiple calls (two or more calls at the same time) are up but coverage at the station is also up. Augmenting this with part-time shifts to keep three people on staff at one time has been successful. Chief Ford stated this is going in the right direction. Mr. Moran voiced concern over the number of false alarms in town and the possibility of instituting a fine for false alarms in town.

# Nelson Burlingame - Building Inspector

The department has been very busy – thus the input of permits into the software is a little behind. There has been a lot of code enforcement, as well as annual 110 Inspections, numerous wood and pellet burning stove installation. Alturist Brewery is moving forward in the Millyard. Holiday Inn Express is nearly half complete. Super 8 Motel needs some code upgrades and has been working with fire, building, and the architect to make the improvements. Historical Commission is concerned with a barn on the Publick House property.

## **Town Administrator's Update**

• Abatement request from Teddy Bachawaty from 14 Meadow View Lane. Problems with some meter readings and the past owner. Mr. Bachawaty moved into town and the previous owner had the sprinkler system go on at night and as a new owner he did not realize the water use was occurring. Ms. Blanchard stated that because the town is only liable for the water use if something such as a water line break occurred. Unfortunately, unless it can be 100% proven that the town in at fault the Board will not be in favor of abatement.

• Town Common Study Committee. As requested by the Board, a report from the Committee suggested for the closing of Morse Street a one-way during events or closing the street completely and the installation of curbing around the common. A full report was provided to the Board. Discussion was had over parking and traffic flow arrangements at the Town Common. Public Comment: Jack Taylor of 8 Morse Street and stated that the road has been there for at least 151 years and the residents were not involved in the discussion of closing Morse Street and there should be more research and discussion on this study. Carol Goodwin also commented that the bright orange barriers that were put up really take away

from the Town Common. The Board agreed they are ugly and are there on a temporary basis. Penny Dumas also spoke in favor of expanding the decisions of the Town Common to a wider audience than just the Town Common Study Committee.

Article 49 - costs associated with Southbridge Landfill Project. Linda Cocalis, chair of the Board of Health, explained what the need and intent is for this Article. A site suitability study will be need completed. A hydro-geologist will be hired to determine how the expansion of the Southbridge Landfill will affect the Town. There is already known

contamination to Sturbridge private wells from the landfill. The \$75,000 request will not cover any legal fees, just research.

Article 52: transfer of funds for the reorganization of the Board of Health. The department is looking to reorganize the staffing arrangement. In this Article, monies previously designated for department head would go towards administration and the health inspector wages. The Board spoke concerns about bringing the hours of the health agent down to part time, when the previous health agent stated she couldn't address everything required within a full time position. More responsibilities could be given to the administration, but the Board would like to see more information to explain the details of this shift in the department.

Discussion: Mr. Moran stated that if the Chair of the Board of Health feels the interim part time agent is able to complete the job in half the time than the previous agent, the Board should support this. Ms. Dowling stated that the Health Agent position has always been full time and the Health Agent also has qualifications and credentials that administrative staff does not possess. In the past the department has always asked for more thus if this change was to occur it would be hard to bring it back to full time.

Ms. Gimas and Mr. Suprenant also agreed that this department change needs a lot more

research and study. This could be a step in the wrong direction for a town with numerous restaurants and hotels.
