July and August operations reports have been submitted. September is on the way. There are 13 residential and 12 commercial meter changeovers outstanding. Consideration of expanding the water ban; the town will skip the fall flushing to help with that. The Fiske Hill pump station plan is almost done. All of Route 20 was camera'd and will be provided to MassDOT. One large water main break at the bottom of Whittemore.

# Kevin Flichak - Economic Development and Tourism.

Economic Development – working to reach out businesses and make contact. The Trolley study involved going business to business and opened up doors for dialogue and discussion between Mr. Filchak and the local businesses. Roughly 300 surveys of the Trolley service were completed. Those businesses not in the study area were sent a letter to establish a connection. Asking business what works for them, what can the Town do to help, what would they like to see moving forward? A common theme was to increase accessibility. In response to this, Mr. Filchak is developing a guidebook regarding permitting, licenses, etc. for residents and businesses owners.

### Fire Chief Ford

Chief Ford discussed the options of replacing the old ladder truck that needs to be replaced. There are several options available, including buying a new truck (very expensive) or buying a used truck (more cost efficient). Chief Ford also working with the capital budget to plan for eventually replacing other equipment too. Chief Ford is asking for \$350,000 to replace the existing ladder truck with the hope of a trade to compensate some of the price of half a million dollars.
