Chairman Blanchard called the meeting to order at 6:30 p.m.

The Selectmen led the Pledge of Allegiance.

M. Blanchard announced that Ronald Wolhouse had passed away and wished condolences to his family and friends.

Public Hearing: Silvertree Reality LLC - Forest Cutting Plan/Logging Permit 550 Route 15

Richard Valcourt came forward, introduced himself and explained that the Forest Cutting Plan for 550 Route 15 is because of insect infestation, they are going to be removing dead and diseased trees and creating an environment for healthy trees to thrive.

M. Blanchard asked if all abutters notice receipts had been returned. R. Valcourt responded that most of them had been but he didn't have them with him. M. Blanchard reminded him that abutter's receipts need to be returned to the Town Hall.

M. Suprenant brought up the Cease and Desist letter that was sent to R. Valcourt by Conservation. M. Blanchard asked when the cutting would begin.

R. Valcourt replied that they plan on starting once the plan is approved by the Board of Selectmen.

Vote to Approve Energy Reduction Plan

Jean Bubon, Town Planner, and Dominique DuTremble, CMRPC, came forward. J. Bubon explained the Energy Reduction Plan and introduced D. DuTremble from the Massachusetts Green Communities Program. D. DuTremble explained the Energy Reduction Plan in more depth. M. Suprenant asked if there were any opportunities for variable frequency drives, electric motors are more efficient. D. DuTremble responded that it wasn't included in this assessment though it should be and that she would like to have a team come out and have a contractor do a study including those items.

M. Dowling asked about street lights using solar energy and burying utility poles and if it would make an impact. D. DuTremble responded that it is something they can look into.

Senior Center Study Committee Update and Warrant Article Support Request

Ken White, Chairman of the Senior Center Study Committee, came forward and explained his requested support from the Board for a Warrant Article regarding either expanding the existing Senior Center, building a new Senior Center elsewhere in town, possible on Cedar Street, or building a Community Center with a Senior Center included.

M. Blanchard asked if they were requesting this Warrant Article for Special Town Meeting or Annual Town Meeting. Since an amount and account number would be needed for the Article, there wouldn't be enough time to put the Warrant on for Special Town Meeting.

P. Gimas asked what the difference would be between this study and the other study that was just finished. M. Blanchard responded that the one already done was a Needs Study and that this is a Feasibility study. P. Gimas stated that in the future shouldn't the Town just spend money once and do one complete study. She also inquired on what would happen to the new floor for the Senior Center if the Warrant is voted on to be renovated.

M. Dowling discussed Needs Study vs. Feasibility Assessment

P. Gimas asked if they could have the Facilities Coordinator decide whether the Town should have a Needs Study or a Feasibility Study or both. M. Suprenant stated that he thinks it's important to have Facilities Coordinator to be involved.

Motion: To support moving forward for Feasibility Study Warrant Article for Annual Town Meeting. By: M. Suprenant

Discussion: The Board discussed doing both studies vs. separate studies – Feasibility Study and Primary Study

M. Dowling asked if the Senior Center Study Committee was amendable to a Community Center. K. White responded that they would be open to it if it was easier to get state funds. P. Gimas asked if the Committee knew if they could get state funds. K. White responded that they have no guarantees.

Gaumond and may also be to increase the salary for the new Town Administrator. M. Dowling asked if the Board would support the Article if the data supported and increase in pay for a new Town Administrator. M. Blanchard stated that she would be amendable to a higher range because the Town will get a better pool of candidates. P. Gimas stated that without an exact amount she won't support that part of the Article. C. Kaibenski stated that he wouldn't want to go above the current salary rate. M. Suprenant stated that he is open to an increase if the data supports it.
