## Town Administrator's Update

T. Kozak discussed the retirement of the DPW Director Greg Morse, stating that the Town Charter dictates that a search committee needs to be created to find a replacement for the DPW Dir. M. Blanchard discussed the people that make up the committee, the Board discussed creating the advertisement.

T. Kozak discussed the Northeast Energy Center proposed LNG Facility in Charlton, stating that he met with a representative from Northeast Energy Center to discuss the Facility.

T. Kozak stated that Sturbridge is now becoming a Complete Streets Community and what that includes.

T. Kozak discussed the MMMA Meeting that he attended with Kevin Filchik, stating that the meeting was about emergency management.

T. Kozak discussed the Sturbridge Tourist Association meeting that he attended.

T. Kozak discussed creating a Disability Commission in Sturbridge and that he had reached out to the Commission to find out the process for Sturbridge. It would have to be accepted at Town Meeting to be created.

## Public Hearing: Forest Cutting Plan - Logging Permit Request - James DiMaio

M. Dowling read the logging permit Legal Ad submitted to the Southbridge Evening News by James DiMaio.

James DiMaio and David Peterkin came forward and J. DiMaio explained why he needed a logging permit. J. DiMaio stated that they would like to do a clean-up of the damaged trees from the Tornado a few years ago and would also like to clean up trees that have been damaged by the Gypsy Moth infestation.

M. Suprenant asked about the two locations that the logging trucks would be using onto Holland Road, and asked if they would be using an existing driveway.

J. DiMaio stated that it is an existing driveway and explained background information around locations trucks would be using.

M. Suprenant stated that there should be coordination between school buses from Holand and Sturbridge and logging trucks and asked for J. DiMaio to check in with them as a precaution. M. Blanchard asked when the project would begin.

J. DiMaio stated that they will delay until either the ground is fully frozen or whenever the ground dries out.

T. Kozak asked how long the project would last.

J. DiMaio stated that it will be a small operation and should only take about a month or so.

#### Hearing: Reinstatement of Class II License - Robert Cassim

James Erdhard, Robert Cassim's Attorney, and Robert Cassim came forward. J. Erdhard read correspondence from Trooper Johnson and Trooper Lawrence and passed out a copy of the alleged forged title.

M. Blanchard brought up the two businesses that are currently in the same zoning site and stated that they would have to go through zoning hearing.

J. Erdhard argued that R. Cassim's license should be given back since there was no foundation for it to be taken away in the first place. He then discussed that the zoning issue shouldn't be a reason why R. Cassim shouldn't get his license back. J. Erdhard said there was no issue with zoning because the tree service company hasn't signed a lease.

M. Blanchard stated that if there is a change in use of the zone then there needs to be a hearing by the ZBU. One business is a tree service business and isn't allowed in that zone. M. Blanchard would like to keep the suspension until the charges go through and after the zoning issues are cleared up.

J. Erdhard stated that R. Cassim has had no prior violations. P. Gimas stated that there have been prior violations.

M. Suprenant asked about his request for Lemon Law violation information and never heard back regarding that issue. M. Suprenant stated that Trp. Johnson had promised to get back to the BOS regarding whether the cars sold by Mr. Cassim had been inspected by a Massachusetts Inspection Agency.

M. Blanchard stated there have been issues, there are issues, and the issues need to be cleaned up before the reinstatement of the license.

M. Dowling stated that she agrees with R. Cassim's Counsel about reinstating the suspended license because the court case was dismissed and the basis of the suspension was due to the pending charges. She further stated that the issue of whether or not Cassim violated zoning bylaws by the use of the premises (other than his auto business) is a separate matter that needs to go through the zoning process in the event that the building inspector believes a violation occurred. The present hearing is not about that issue. M. Dowling further stated that the State Troopers should have attended the meeting to give back up information and testimony regarding the assertions they made in their emails to the BOS.

P. Gimas stated that she thinks the hearing should be put on hold and continued with the StatePolice in attendance to give their statements.M. Blanchard agreed.

Motion: To continue hearing until November 19, 2018 with request that the State Police attend. By: P. Gimas 2<sup>nd</sup>: M. Suprenant Vote: 3-2 (M. Dowling & C. Kaitbenski Opposed)

P. Gimas asked the Building Inspector, N. Burlingame, for a report regarding the zoning concerns for the November 19<sup>th</sup> meeting.

J. Erdhard requested that he be copied on all communications with R. Cassim.

## Ed Galonek - Abatement Appeal for Water and Sewer Charges

Ed Galonek came forward and introduced himself.

M. Blanchard discussed that it was too late to appeal the charges and that they had him at the meeting as a curtesy.

Ed Galonek discussed what happened regarding a \$6000 water bill over ten day period and that it was most likely stolen.

M. Blanchard stated that if it was a tenant issue then it should be taken care of through the courts.P. Gimas stated that the water should have been shut off on the street and not just in the house.M. Blanchard stated that the Board of Selectmen doesn't have a right to make a decision because the Town isn't at fault.
