

### **ARCHITECTURAL DESCRIPTION:**

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

The Otis E. Leach house at 8 Fiske Hill Road is an example of the early twentieth century upscale residential growth and development along Fiske Hill Road, as the area shifted from agricultural to residential use. This one and a half story Classical Revival style single family dwelling is set up on a hill, with a parcel that contains a perimeter stone retaining wall and is partially obscured by trees. The residence appears to be two or more bays wide by four bays deep, with a clapboard exterior. It has a moderately pitched, side gable slate roof with a cross gable dormer, overhanging eaves and a bracketed cornice. A one story colonnaded porch with elaborate porch support columns and a masonry porch skirt extends along the main, western facing façade and wraps around the southern elevation. There is an exterior brick chimney on the southern elevation.

The main, western facing facade has a pair of first story tripled windows (currently 1/1) and a grouping of three 1/1 windows in the upper half story cross gabled dormer. Five, elaborate, fluted wood porch columns extend along the western edge of the porch and there are additional columns around the southern side. There is an entry and additional fenestrations on the southern, first story elevation and upper half story tripled 1/1 windows are set within the gable. The northern elevation has first story windows, obscured by shrubbery, and a trio of upper half story 1/1 windows set in the gable, matching the main façade upper story windows. Overhanging eaves and a bracketed cornice are visible from this perspective as well. The northeastern corner of this elevation contains a one story shed roof ell with a secondary entrance and a 1/1 window on the ell's western elevation.

A one story, two bay wide garage outbuilding is to the northeast of the residence, accessed by a paved driveway. It has a side gabled roof and a one-story carport off of the southern elevation.

### HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

Fiske Hill refers to the "first permanent European agricultural settlement after circa 1725" which was established in the Eastern Upland area of Sturbridge.<sup>1</sup> In 1731, brothers Henry and Daniel Fiske settled on the hill, prior to the 1738 incorporation of the town of Sturbridge. These men and their descendants "were important not only on the hill as farmers and founders of the Baptist church there, but also in town government and, by the 1800s, in industrial enterprises in Globe Village, Westville, and Fiskdale."<sup>2</sup> Fertile soil made this area ideal for agriculture and by the late eighteenth century, Fiske Hill had also developed as a stagecoach road with a Baptist Meeting House, School, and Inn. By the early to mid-twentieth century, development shifted from agricultural towards higher-end residential growth.

In the 1870 census, Otis E. Leach (1865-1940) was living with his parents, Civil War veteran Ebenezer Leach (born ca. 1837, died prior to 1890), who was listed as working in a Cotton Mill and Lucretia P. Leach (born 1835), and the deeds connected to this property are described as a portion of the premises conveyed in 1897 to Otis by Lucretia, and also from his brother, Thomas L. Leach (born 1869) in 1907, which was presumably family land.<sup>3</sup> (Figure 1) In the 1900 census, Otis was listed as a Boss Carder at a Wool Mill.<sup>4</sup> Otis and Margaret (Maggie) Justice Leach (1888-1973) were married in Sturbridge in 1924 and




Figure 3: Otis E. Leach residence is circled, 1931 Land Plan, note additional properties owned by Leach

remained residents.<sup>5</sup> By 1936, Oits is listed as a carpenter who resided at Fiske Hill.<sup>6</sup> In the 1940 census, he is noted to be employed as a painter.<sup>7</sup> Otis was also a landowner of several other parcels along Fiske Hill Road. (Figure 3)

Archie J Gagnon (1913-1980) and his wife, Antoinette S. Gagnon (1913-1999) were residents of 8 Fiske Hill Road as early as 1949, according to the local Southbridge directory.<sup>8</sup> In the early 1950s, Archie was employed as the treasurer and sales manager at Arland Tool Manufacturing and was also formerly the treasurer at Cedar Lake Enterprises, Inc.<sup>9</sup>






