ABSTRACT

The Sturbridge Historic Resources Inventory was commissioned by the Town of Sturbridge, to be administered by the Sturbridge Historical Commission (SHC), and prepared by the Pioneer Valley Planning Commission (PVPC) throughout 2016 and 2017, supported by Sturbridge Community Preservation Act funds. This report discusses the methodology, results, and final recommendations of the four-phase project, which took place during 2016 and 2017. Phases I and II organized the research, clarified the list of historic resources to be documented, and produced representative samples of inventory forms. Phase III involved completion of field work, and researching, writing, and ultimately submitting the remaining inventory forms for review to the SHC chairperson. Data was collected through field work and site photography, as well as by using on-line access to archival databases for newspaper, map, and deed research. The Phase IV final products include a comprehensive inventory and related mapping of approximately 100 of Sturbridge's historic built resources, as well as this final report which summarizes project findings and offers recommendations for future actions. The resulting data, including National Register Criteria Statements for some of the more significant buildings and sites, will be available for public access at the Sturbridge Town Hall and through the Massachusetts Cultural Resource Information System (MACRIS).

METHODOLOGY STATEMENT

Survey Objectives and Assessment of Previous Research

The most recent comprehensive Sturbridge inventory was completed in the early 1970s. Around that time, a National Register District was established which focused on the town center along the Main Street corridor. This 2016/2017 survey is an effort to provide documentation which is up to current standards for some of the previously researched buildings and to thoroughly document additional significant resources, including newer buildings which may now also be considered noteworthy.

Selection Criteria

The Pioneer Valley Planning Commission's previous Historic Preservation Planner, Elizabeth Rairigh, worked with the SHC, and in particular, chairperson Barbara Search, to formulate a list of resources to inventory. Existing forms in MACRIS were reviewed and properties were identified as the original inventory did not have building addresses. A list was compiled of properties constructed prior to 1968, most of which were not in the previous inventory. Preliminary field work included checking priority areas identified by the SHC and properties referenced in previous reconnaissance surveys. The result of these efforts was a list of more than 100 resources, plus related outbuildings and structures for potential inclusion in this inventory.

The list was narrowed to the most significant resources using the following criteria:

- Historic buildings that are potentially threatened, including some which were previously inventoried;
- Historic buildings which appear to be eligible for the National Register, either individually or related within a district
- Historic buildings with special significance to Sturbridge; and/or
- Architecturally distinguished historic buildings, or those that are an excellent example of style, with moderate to good integrity.

The preliminary list was evaluated and finalized by the Sturbridge Historical Commission and field work commenced in the Spring of 2017.

• Survey Procedures

The survey was initiated by previous PVPC Historic Preservation Planner, Elizabeth Rairigh, with the support of subcontractor and preservation consultant, Shannon Walsh. Due to a staffing change at the end of Phase II, the remaining work on Phase II, Phase III, and Phase IV was completed by Walsh, who was hired as the new PVPC Historic Preservation Planner, with the support of veteran historic preservation consultant Bonnie Parsons.

The survey followed MHC guidelines and utilized MHC Building and AREA form templates. Base forms were established with assessor's numbers and USGS Topographical Quadrants, and existing MACRIS and West Springfield Assessor's database files were reviewed to get preliminary information on the buildings, sites and areas. Form locational maps were accessed through OLIVER, the MassGIS online mapping tool. Photographs were taken in March and April of 2017 from the public right of way. Primary and secondary sources were used for research to write historical narratives. Although this was outside of the original scope of work, challenges with typical avenues of research often necessitated comprehensive deed searches if the information was relevant to the history and significance of the building or if this practice proved to be the best source of elusive data. Building, Structure, and Area numbers were provided by MHC and were added to forms and crossed referenced on the index within this report, and the final base maps and required corresponding information were produced by the PVPC GIS department.

Products and Accomplishments

The project has resulted in a community-wide survey documenting or bolstering existing documentation of approximately 100 of Sturbridge's historic resources, as well as related National Register Criteria Statement Forms for buildings or areas which were deemed significant.

Copies of the inventory forms, base maps, and final report will be available in the Town Clerk's Office at the Sturbridge Town Hall, located at 308 Main Street. Electronic copies of the inventory forms will also be uploaded into MHC's on-line repository, MACRIS, for public access.

Results versus Expectations

- Advertising in the local paper by the Sturbridge Historical Commission helped inform
 residents that there would be someone documenting local buildings. There were still some
 concerned property owners who came out to ask about the project and ensure that the
 photographer had good intentions.
- Buildings which were obstructed from view or set far back from the public right of way were challenging to document. Obtaining advance permission from owners with less visible properties or with multiple resources on a property would have helped to ensure better access.
- When owners were outside, greater access could sometimes be achieved, such as the visit to 13 Podunk Road (STU.289) which led to the documentation of a barn foundation which could not have been viewed from the public right of way.

- The wide geographic area covered in this survey made site visits and photography take longer than expected.
- Sturbridge has narrow roadways with few places to park, particularly in some of the residential areas, which made photographing some of the resources challenging.
- The inventory research from the early 1970s was very helpful in providing information on buildings which had been included in that project. Utilizing census information and town street directories was surprisingly challenging as Sturbridge did not list street numbers, and sometimes not even street names of residents on this type of documentation from the time period researched. More intensive deed searches, which were not originally planned for within the project scope or work, were often required in order to better determine building ownership and potential construction dates.

NATIONAL REGISTER

For the purpose of this survey, National Register context was determined by applying the following criteria to a building or area:

The quality of significance in American history, architecture, archeology, engineering, and culture is present in districts, sites, buildings, structures, and objects that possess integrity of location, design, setting, materials, workmanship, feeling, and association, and:

- **A.** That are associated with events that have made a significant contribution to the broad patterns of our history; or
- **B.** That are associated with the lives of significant persons in our past; or
- **C.** That embody the distinctive characteristics of a type, period, or method of construction, or that represent the work of a master, or that possess high artistic values, or that represent a significant and distinguishable entity whose components may lack individual distinction; or
- **D.** That have yielded or may be likely to yield, information important in history or prehistory.²

DISCUSSION OF NATIONAL REGISTER CONTEXTS AND PROPOSED LISTINGS

At the beginning of this project, in the fall of 2016, it was determined that MACRIS had 214 entries for Sturbridge, to include seven areas, 194 buildings, 2 cemeteries, 10 monuments, and one boundary marker shared between Brimfield and Sturbridge.³

The town also has approximately 50 properties listed on the National Register. The prominent Sturbridge Common Historic District (STU.A), listed in 1977, includes 47 resources on Main Street between Hall Road and the Interstate 84 overpass. There is also the Sturbridge Center School (listed1977), the Tantiusques Reservation Site (listed 1983), and the Oliver Wight House (listed 1982).

This survey has identified buildings which are relevant within the context of Sturbridge's local history and contribute to a greater understanding of the town's eighteenth, nineteenth, and twentieth century community growth, development, social, and industrial history, and are additionally representative of architectural styles from the periods in which they were built. The highlighted buildings and area proposed for National Register consideration were constructed in and are relevant to eighteenth, nineteenth, and twentieth century contexts, and all have a local level of significance.

The <u>Haynes Corner Area</u> (ca. 1780-1912) is representative of a collection of late eighteenth to early twentieth century residential and industrial buildings, with light industrial and Federal architectural style. The area is related to the Haynes family, who supported not only local commerce and agriculture, but also contributed to town affairs.

The eighteenth century <u>Joseph Marsh House</u> (c. 1760) and <u>Eliab and Fanny Marsh House</u> (c. 1795), both on Brookfield Road, follow the pattern of the town's larger history, with family farmsteads, developed by ancestors of the first generation of Sturbridge settlers. The Joseph Marsh House is a well-preserved Georgian style residence which maintains its farmland setting. The Eliab and Fanny Marsh House has elements of both Georgian and Federal style.

Along Champeaux Road, there is the <u>Eli and Mary Marsh House</u> (ca. 1762), which represents the town's residential and agricultural growth and development from the eighteenth century onward, and is a good example of a Georgian Saltbox form residence.

The <u>Samuel and Mary Morse House</u> (ca. 1800) on Farquhar Road, relates to several generations of the Morse family and is an example of the town's agricultural history throughout the early nineteenth to midtwentieth centuries. It is also a good example of a Georgian-style house in a rural setting, with related outbuildings.

The well-preserved Georgian-style <u>Samuel Hobbs House</u> (ca. 1775), on Hall Road, was home to four generations of the Hobbs family, who were active in agriculture, the local economy and government, as well as the formation of the local agricultural society.

Statements were also prepared for the Italianate style <u>Snellville District #2 Schoolhouse</u> (1874) and the Gothic Revival style <u>Otis Block</u> (ca. 174-1880), both on Main Street and related to industrial and consequent community growth and development in the Snellville and Fiskdale areas of Sturbridge. The schoolhouse inventory form and related National Register Criteria Statement were expedited due to a proposal to alter the existing windows. Both buildings relate to community planning and development, local industry and commerce, and social history, and are also significant for architectural style.

The Federal style <u>John Smith House</u> (constructed by 1857) and related outbuildings are relevant as examples of the early residential and agricultural growth and development of McGilpin Road, in the Fiske Hill area, and of the social history of the Smith family (ancestors of one of the first proprietors).

Another former significant residential and formerly agricultural property is found on Old Stagecoach Road. The <u>Abner Allen House</u> (1735-1772) is connected to multiple generations of the Allen family, who had agricultural and industrial ties to the area, and the residence provides a sense of the mid to late eighteenth century streetscape

Podunk Road has some interesting resources, to include the <u>George J. and Delina D. Cloutier House</u> (1946) and related, older, outbuilding and barn foundation, and the <u>Jonas Bemis/Silverberg Family House</u> (built by 1850) and related outbuildings. Both properties span Sturbridge history and relate to patterns of residential growth development, along with agricultural practices. The Cloutier House, among one of the newer buildings on this survey, is a very interesting style of masonry Colonial Revival architecture and there are significant agricultural-related built resources on the property as well. The Bemis/Silverberg House has ties to the community's residential and agricultural growth and development, social history (particularly through at least two generations of the Silverberg family), and architecture, as an example of Colonial architecture with later alterations and with a related, well-maintained and stylized barn on the property.

The Georgian style <u>Hamilton Woolen Co. House</u> (built by 1805), in Westville, and Queen Anne style <u>Fiskdale Mill Agents House</u> (ca. 1875), in Fiskdale, are also architecturally significant and are additionally related to local industry and the area's nineteenth century community growth and development in the mill villages.

To summarize, the following area and buildings are recommended for listing on the National Register of Historic Places:

- Haynes Corner Area District (307, 315 Main Street and 5 Haynes Street)
- Joseph Marsh House (142 Brookfield Road)
- Eliab and Fanny Marsh House (213 Brookfield Road)

- Eli and Mary Marsh House (12 Champeaux Road)
- Samuel and Mary Morse House (47 Farquhar Road)
- Samuel Hobbs House (23 Hall Road)
- Snellville District #2 Schoolhouse (480 Main Street)
- Otis Block (572 Main Street)
- John Smith House (138 McGilpin Road)
- Abner Allen House (3 Old Stagecoach Road)
- George J. and Delina D. Cloutier House (13 Podunk Road)
- Jonas Bemis/Silverberg Family House (251 Podunk Road)
- Hamilton Woolen Co. House (210 Shepherd Road)
- Fiskdale Mill Agents House (11 Summit Avenue)

National Register listing is an acknowledgement of the criteria-based significance of a building or related buildings. This listing does not place restrictions on an individual homeowner and only provides limited protection against demolition but can serve to "encourage respectful treatment through public recognition of the property." Individual homeowners will not face restrictions due to a listing. National Register listed commercial properties could qualify for federal rehabilitation tax credits and listed buildings owned by municipalities or non-profit entities can compete for state preservation funds.

RECOMMENDATIONS FOR FURTHER STUDY OR ACTIONS

- Using the Fiskdale AREA form from the 1970s as a starting point, identify boundaries for the
 Fiskdale area and investigate the feasibility of a district. If there has been too much alteration to
 the area, consider creating individual building National Register nominations or, to provide greater
 protection, create Local Historic Districts (LHD) for individually significant buildings or contiguous
 groupings of buildings in order to protect and maintain architectural integrity.
- If Local Historic Districts are viewed as too restrictive, consider developing Neighborhood
 Architectural Conservation Districts (NCD) for areas (such as Fiske Hill) where there is a desire to
 maintain distinctive characteristics of a neighborhood or streetscape, and to focus on particular,
 significant details (such as key architectural elements, massing, scale, and setback), with
 proposed changes reviewed by a Neighborhood Architectural Conservation District Commission.⁶
- Reach out to owners of inventoried properties to share the history of their buildings with them.
 Several owners who were encountered during the field work showed interest in the results of this survey.
- Explore the possibility of securing preservation restrictions on significant buildings, in order to ensure the long-term protection of significant, character defining details.
- Consider historic landscape preservation of agricultural landscapes a priority to ensure that the
 town's agricultural heritage remains intact for future generations. Conservation easements may
 support this endeavor. The 2007 reconnaissance report also has additional suggestions
 regarding the preservation of scenic roads and other approaches to preserve the historic rural
 nature of Sturbridge, while supporting local economic growth.⁷
- Bolster existing historical archives

- Copy extant town reports, which may be available at other locations such as the state library, and add to the Joshua Hyde Public Library local history collection or to the collection of more recent town reports at the Town Hall. Have a finding aid at the Hyde Library of the town materials which are located within Old Sturbridge Village archives.
- Work jointly with Old Sturbridge Village on documentation projects for the town's earliest and most significant properties and on the organization of the town's historical archives to support future research projects. For example, consider using interns on specific projects such as tracing the land deeds of the town's early significant residents who were involved with the development of Sturbridge.
- Reach out to local preservation or history programs such as the one at the University of Massachusetts, Amherst campus, for students interested in undergraduate or graduate internships on specific, short-term research projects.
- Explore other ways to increase public knowledge of the built history of Sturbridge and to support heritage tourism or eco-tourism:
 - Add wayfinding signage to significant buildings or sites, explaining what purpose these resources served in town history. Create walking or driving tours related to these resources.
 - Reach out to developers who buy or currently own important historic resources so that they
 are aware of their property's significance. While some buildings have had alterations and
 have lost some architectural integrity, many still retain interesting character-defining features
 and remain important to understanding the history of Sturbridge.
 - Collaborate with and utilize other local, regional and statewide organizations (such as Old Sturbridge Village, the Sturbridge Community Preservation Committee, the Sturbridge Cultural Council, the Sturbridge Conservation Commission, the Chamber of Central Mass South, the Regional Tourism Council, Preservation Massachusetts, the Trustees of Reservations, and the Massachusetts Historic Commission) to plan programming or initiatives as public outreach to work towards common goals like preservation, sustainable design, and promoting the use and understanding of the town's many cultural assets. Work with local schools to instill pride and a strong sense of place in Sturbridge youth and allow teachers to use local historic resources as teaching tools. Co-sponsored events and other shared resources would help to promote and support overall preservation endeavors.
