



ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

The Fiskdale Mills Co. Farm House, at 16 Summit Avenue, is an example of a nineteenth century residence and outbuilding which show the residential growth and development of the Fiskdale section of Sturbridge and are further related to Fiskdale's industrial growth. The residence has undergone alterations and its original form is obscured. It is approximately seven bays wide by five bays deep, to include presumed additions to the main, original residence. The foundation is brick and concrete, and the exterior is clapboard with wood trim. There is a side gable, asphalt shingle roof on the central, residential section. All windows appear to be 1/1 replacements.

The northern facing front façade has a two and a half story, five bay wide central section. Windows are 1/1. A centered entry is covered by a modern, shed roof covered deck, accessed by stairs. A two story flat roof side wing, off of the eastern side of the central section has an additional entry at the northeastern corner, and a single 1/1 first story window and a grouping of three 1/1 windows on the second story. The eastern side of the wing has two sets of paired, 1/1 windows on the first and second story. This section of the building has a crawl space beneath, rather than a foundation and is elevated by concrete blocks and posts. serving as footers. An additional north/south aligned wing has a gabled roof and a shed roof dormer on the eastern elevation. The southern facing, gabled end of this wing has an additional entrance.

An additional outbuilding on the property, located to the south of the residence, has clapboard siding and wood trim, and a side gable roof with overhanging eaves. (Photo 4) The northern facing side elevation is most easily viewed and has a first story entry and window, and an upper half story entry set within the gable. A shed roof and support posts, similar in style to the exterior feature on the northern facing main facade, provides shade off of the western side elevation.

HISTORICAL NARRATIVE

This area was formerly the heart of Sturbridge industry. It is in proximity to the site of an early grist mill, which was developed by Captain Jacob Allen, descendent of first settler Moses Allen, and his progeny, and further advanced by the Hon. Josiah.J. Fiske (1786-1838), and later members of the Fiske family. A new, brick cotton mill was finished by 1829 and a stone mill was added by 1835, along with the formal incorporation of the Sturbridge Cotton Mills.¹ A post office was opened in 1842 and the village was named Fiskdale.² The Fiskdale Mills Agent's House Property, constructed between 1870 and 1898, is to the north of this residence, also on Summit Avenue. (STU.301) (Figure 4)




Figure 1: 1857 Map with Fiskdale Inset

Farmer Avery P. Taylor, Esq. (1795-1881), husband of Anna D. Taylor (1799-1871), is noted on an 1855 census, near an entry for William B. Whiting (1818-1894), who is listed on an 1857 map as owning property near the cotton mills in Fiskdale and was the mill agent after 1854.^{3 4} (Figure 1) In 1868, Taylor sold land related to this property to the Sturbridge Cotton Mills, but as his name does not show up on the 1857 map, it is unknown if there were buildings on the site at that time.⁵ (Figures 1 and 2)






Figure 3: 1870 Map




Figure 4: 1898 Map showing Fiskdale Mills Co. Farm House

There is also no notation regarding these buildings on an 1870 map of this area (Figure 3). By 1898, this property is connected to the Fiskdale Mills Company, as a Farm House, with related agricultural outbuildings. (Figure 4) With changes of ownership, it

was later passed on to the Fiskdale Finishing Company, the Golding Brothers Company, and the Sturbridge Printing and Finishing Company.⁶

By the mid-twentieth century, owners were Philias V. (1897-1958) and Gertrude M. Ledoux (1898-1990). Around that time period, Gertrude is noted to be proprietor of the "Hilltop Guest House" ^{7 8}


