NEW BUSINESS

- 1. August Concerts on the Common Discussion. AR shared that guidelines have been updated however they have become more strict with additional requirements. There is still a maximum of 100 people including bands, staff, audience. A singer can now be 10 ft apart from other band members, who must now be wearing masks during their performance. AR verified our biggest concern, crowd sized, has not been changed at this time. CF agreed we are in the same position as a month ago and we lack the man power for enforcement. AR shared that she did contact the high school with the idea of a drive in concert, but the high school is unable to support the event at this time.
 - a. EC made a motion to cancel the remained of the Concert Series. Seconded by KP. Vote 3-0.
- 2. Bandstand and Pavilion maintence. AR reviewed the quotes that were distributed to the Committee. Quote 1 is for the Recreation Area Pavillion, Andrew Porter Contracting, grand total of \$4,100.00. The second quote is for GHB construction for general maintence on the Town Common. This work was organized through Bob Briere in preparation of what would have been our Silver Anniversary Celebration.
 - a. EC made a motion to accept the \$4,100.00 quote to repair the Recreation Pavillion. Seconded by KP. Vote 3-0.
 - b. EC made a motion to accept the \$1,533.32 quote for general maintence repairs on the Town Common gazebo. Seconded by KP. Vote 3-0.
- 3. Update on Youth Educational Programs. AR provided an update on the current outdoor classes and the positive feedback and attendence levels we're received so far. While one class was canceled due to lack of registration (dance and yoga), other classes such as Tennis, Arts, and Fitness will be adding additional sessions due to high attendence.
