NEW BUSINESS

- 1. Update on Concerts and Summer Programs. AR provided the Committee with full food truck vendor schedule and an update that Beer Vendor Greater Good has submitted their application to the Sturbridge Police Chief. AR shared that there are currently 75 registered for Summer Recreation, progam begins Monday 6/28.
- 2. Discussion on Color of Pickleball Lines, Cedar Rec Courts. Recreation Committee revisited the request of changing Pickleball lines (will be on both courts ultimately) to light blue now that repairs are underway. The courts are currently yellow. Pickleball has been asked to share any comments if opposed and has stated that they are not opposed to changing the PB lines to a different color. MV made a motion clarify the specific shade of light blue with Sturbridge Pickleball to move forward. Seconded by CF. 4-0.
- **3.** Annual League Funding Warrant. AR reviewed excel spread sheet for annual funding break down. Funding allocations are pending invoices for reimbursement only, stipends not permitted for leagues who were unable to play due to COVID. Sturbridge Girls Softball with 130 players was allocated up to \$1,653.40, Sturbridge Rec Soccer with 260 registered allocated up to \$3,304.60, and Sturbridge Little League with 200 players was allocated up to \$2,542.00.

JK made a motion to approve 2021 League Funding Requests, seconded by MV. Vote 4-0.

- 4. Request for Beer Vendor- Concert Series. Reviewed above.
- **5.** New Event, Fall Town Wide Yard Sale. AR provided 2021 Town Calendar of events and suggested date of Sat and Sun 9/18 and 19th due to fall schedule of activities. AR stated this event is for residents and nonprofits only, as local businesses would require a different permit.

MV made a motion to host the Town Wide Yard Sale on 9/18 and 9/19, 8:00-3:00 PM. Seconded by JS. Vote 4-0.

- 6. New Program Continued, Fall Fun Series- Saturdays. AR shared that one fall trail walk with FRoST for "Walktober" with LGV has been scheduled. AR hopes to host more classes similar to spring session, a variety of local businesses.
- **7. 2021 Fall Bonfire.** AR shared that Special Events Committee has transferred the Bonfire to Rec Dept. AR has asked for verification that allocated funding was included. Fall Date TBD pending Tantasqua fall schedule of activities. This is a week night 4 hour event typically, AR will contact band from prior years that provided 2 hour cost for 4 hour performance.
