**OPENING OF MEETING** MV made a motion to open meeting at 4:05 PM

**APPROVAL OF MEETING MINUTES** 3-30-22 MV made a motion to accept the minutes, seconded by JK. 4-0.

#### **NEW BUSINESS**

1. The Recreation Committee welcomed Josh Cottone to his first meeting as a Committee member.

## 2. Discussions for Summer Recreation Program

- a. Program attendee applications now available on Town website. AR shared that registration is now open; program begins Monday June 27 2022 and will run for 8 weeks. There will be two weeks of the Mini Rec Program. The regular program runs from 8:00-2:00 PM. AR shared that currently two field trips are scheduled, Interskate and Lupa Zoo. Educational Programs will return to Rec as well, so far Out of the Ark is scheduled for both regular program and mini program. There is no cost increase for registration in 2022.
- b. **Review schedule, staffing, field trips.** AR provided an update on current staffing, all but two will be returning to their seasonal positions in 2022. AR congratulates the two staff not returning on new employment opportunities as they enter their careers. The position of seasonal playleaders were advertised in the paper and online. After reviewing with Summer Program Coordinator Genny Pacitti (GP), AR and GP presented the following staff recommendations;
  - i. Retain employment for all current Staff of Summer Recreation Program
  - ii. Hire Andrew Campiglio and Carrie Nollstadt for Seasonal Playleaders
  - iii. Hire Claire Rogers, Christina Ghantous and Emma Quinn for Substitute positions. MV made a motion to accept and support Staff Recommendations and to hire the personnel referenced above, seconded by JK. Vote 4-0.
