RECOMMENDATION OF THE SELECT BOARD:

That the Town vote to transfer the sum of TWENTY-SEVEN THOUSAND SIX HUNDRED NINETY-TWO AND 00/100 DOLLARS (\$27,692.00) from Free Cash for the purpose of funding the Snow and Ice Removal account for FY2024. Voted 4 - 0 - 0.
