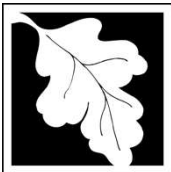

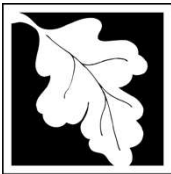
A.6. General Project Description

Site: 113 Brookfield Road, Fiskdale

Applicant: Matthew & Abigail Hurton

The applicant proposes to remove 4 trees, which are shown on the site plan, and replace them with 8 plants (5 Sweet Pepper Bush and 3 Speckled Alder). In addition, due to the high groundwater table surrounding the house and under the garage floor, the applicant proposes to remove the concrete floor from the garage and place 4 French drains within the garage. He also intends to install a French drain around the house and connect them to the garage French drains. The French drains will discharge onto a bowl-shaped pit lined with filter fabric and 2" stone directly upgradient of the wetlands. Lastly, the applicant proposes to add a 12' wide driveway extension south of the existing driveway.

The erosion control measures of staked 9" straw wattles, shown on the site plan, shall be placed prior to site work. These measures shall be maintained in good working order throughout the project until all exposed soils are final graded, loamed, seeded and stabilized with well-established soil stabilizing vegetation.
