Applicant for Architectural Design Request:

• The applicant is requesting a partial interior renovation related to non-load bearing partitions, finishes, and millwork and some exterior improvements. Exterior renovations are largely limited to the West Elevations and are a replacement of the existing gable entrance overhang. The overhang and columns will be removed, and a new structure built on the existing foundation will be added. Brick columns and a brick tower framing the entrance will support a hardi board-clap board façade. A wood toned Fiberon panel will line the interior of the tower, and new lighting is also

included. The exterior skin will be painted and new roofing installed to also match the new entrance overhang color and detailing. There are no site improvements other than the addition of a 2 riser stair on the north side of the existing overhang foundation.
