




Q2 Are you a Sturbridge resident?





Q6 Which of the following attributes were most influential in your decision to reside in Sturbridge?



Q7 Do you plan to live in your current residence as you age into retirement?







Q9 How important is it for you to remain in your community as you age?







Q11 Is housing affordability an issue for you or anyone you know who lives in Sturbridge?








