• In March:

 There were 4,574 total trail visitors based on Trafx counter data. This is a decrease of 65 visitors as compared to last month. This data includes traffic from Leadmine, Riverlands, Heins Farm, Plimpton, and Long Pond trail heads.

 The most visited property was Leadmine (Shattuck, Morgan, Pinelands) with 3,494 visitors, followed by Riverlands with 600 visitors, Heins Farm with 219 visitors, Plimpton with 137 visitors, and Long Pond with 124 visitors.
