REVIEW of PRIOR MEETING MINUTES:

- The two easements behind Paw Plaza were also approved but need to get to town meeting for final approval.

 - Got approval from ConCom to replace the culverts at Long Pond
 - Brian and Kathy Peterson will oversee the project
