# Introductory Discussion on Equestrian Center (TC recuses himself from discussion)

- Lot is on east side of Rt. 84 near CT boarder. Roughly 240 acres of land. Property will host horse races, riding lessons, agriculture education and trails opportunities. Access is only through Rt. 84. Completely green project. Will have biomass conversion system. Trail system would add 2.4 miles of trail. Maybe a pump track. Asking for input from STC on what is needed or desired from STC.
- Equestrian Center project is asking for assistance in designing trails.
  Equestrian Center will own and maintain any trails on property. STC would request ADA compliant trails. Trails will be part of the Host Community Agreement. 18 24 months to break ground. STC can have input into what type of trails are included in the project.

# Trail Counter Data:

- July adjusted traffic data for all trails with counters was 6,166 as compared to July 2020 adjusted traffic count of 4,771.
- 2021 YTD adjusted traffic is 47,485 compared to 37,270 for the same time period in 2020. Note: Shattuck counter added in Sep. 2020.

#### **REVIEW of PRIOR MEETING MINUTES:**

- Review of the July 8, 2021 STC meeting minutes. TC motions to approve the meeting minutes as written. RP seconds the motion. Vote 4-0.

#### **BUDGET:**

- TC provided overview of STC budget
  - \$16,319.99 expenditures to date mostly due to two SCA hitches which cost \$8K a piece
  - o Equipment repairs needed on RTVs

## TEA GRANT:

 TC provided a brief update. Additional costs are causing the project to be reevaluated again. Original earmark of \$550K. Then got \$300K more from MassTrails grant. • Upcoming hearings on Oct 5 and Oct 12. These are required before construction can begin.

#### **GRANTS:**

- Riverlands Flow trails grant. All bids came in over allocated \$75K funding. Will reject existing bids. STC will reduce required trail footage to reduce cost and go out for another round bids. STC will also ask for more funding to cover all costs for total footage of planned trail.
- Riverlands parking lot grant. Now have a contract in place to start construction of parking lot and 1000 feet of trail. Northern Tree cut all the trees in preparation for parking lot. December 2021 completion date required by state grant.

- May want to change the name of the day to remove Workday from description. Make sure everyone knows its volunteer work. Suggestion is to put QR code on all maps on kiosk to get more information about volunteering.
